

Terms and Conditions

Please read these terms and conditions carefully before using Our Service.

Definitions

For the purposes of these Terms and Conditions:

- **“Account”** means a unique account created for You to access our Service or parts of our Service.
- **“Company”** (referred to as either "the Company", "We", "Us" or "Our" in this Agreement) refers to eLuna.com
- **“Country”** refers to Israel.
